ETHICAL DECISION MAKING AND CONFLICTS OF INTEREST A guiding checklist for Councillors, Officers and Advisory Committees

Ethical Decision Making

- Is the decision or conduct legal?
- Is it consistent with Government policy, Council's objectives and Code of Conduct?
- What will the outcome be for you, your colleagues, the Council, anyone else?
- Does it raise a conflict of interest?
- Could your possible conflict of interest lead to private gain or loss at public expense?
- Can the decision be justified in terms of public interest?
- Would it withstand public scrutiny?

Conflict of Interest

A conflict of interest is a clash between private interest and public duty. There are two types of conflict:
 Pecuniary – regulated by the Local Government Act and Office of Local Government and, Non pecuniary – regulated by Codes of Conduct and policy. ICAC, Ombudsman, Office of Local Government
 (advice only).

The test for conflict of interest

- Is it likely I could be influenced by personal interest in carrying out my public duty?
- Would a fair and reasonable person believe I could be so influenced?
- Conflict of interest is closed tied to the layperson's definition of "corruption" using public office for private gain.
- Important to consider public perceptions of whether you have a conflict of interest

Identifying Problems

1st - Do I have private interest affected by a matter I am officially involved in?

2nd - Is my official role one of influence or perceived influence over the matter?

3rd - Do my private interests conflict with my official role?

Whilst seeking advice is generally useful, the ultimate decision rests with the person concerned.

- **5.1.3** Guest speaker for Access Awards confirmed: R McDonell informed the committee that Alison Wason had gratefully accepted an invitation to be the guest speaker at the upcoming 'Day of People with a Disability' celebrations.

- **Grant application from West Wyalong Advocate**: It was noted that a grant application from the West Wyalong Advocate has been received however a Development Application (DA) will need to be lodged and approved before the application can be processed. This application will be presented to the committee for consideration once a DA has been approved.
- **Grant application from Weethalle Country Club:** It was noted that a grant application from the Weethalle Bowling Club has been received however a Development Application (DA) will need to be lodged and approved before the application can be processed. This application and will be presented to the committee for consideration once a DA has been approved.
- **6.4 Disability Inclusion Bill 2014:** A fact sheet outlining the draft '*Disability Inclusion Act 2014* (NSW)' was provided to the committee members. This was discussed by the committee. It was noted that Council will be required to develop a Disability Action Plan by 2017. It was requested by committee members that they be invited to attend if any training on the new act is conducted.
- **Mobility Access Map:** It was reported to the committee that the mobility map is in the process of being updated and has not yet been completed. It was requested that the map be completed in time to be launched at National Day of People with a Disability celebrations, however it was further noted that this may not be possible due to the current demanding workload of Council's GIS staff.
- **Access Incentive Scheme Grant guidelines review:** It was reported to the committee that a review of the Access Incentive Scheme grant guidelines is currently underway. The Community Development Officer is to complete a draft version and provide to the committee at the next meeting for comment and consideration.
- 6.7 National Day of People with a Disability and Access Award preparations: The Committee reported that Café Peckish would be a suitable location to hold the Celebrations. Access awards will be provided to those businesses that have improved access to their premises within the past financial year. Advertisement will occur through usual channels and skills options will be contacted to see if they would like to have a stall of goods for sale on the day. Alison Wason will be contacted again to confirm her speech. Wendy Bowles will MC on the day. The event will commence at 10:30am.



2014 Expenditure by geographic area





2014 Expenditure by issue













Sat Image February 2014 Lake level (2010 – 2014)


