ETHICAL DECISION MAKING AND CONFLICTS OF INTEREST A guiding checklist for Councillors, Officers and Advisory Committees

Ethical Decision Making

- Is the decision or conduct legal?
- Is it consistent with Government policy, Council's objectives and Code of Conduct?
- What will the outcome be for you, your colleagues, the Council, anyone else?
- Does it raise a conflict of interest?
- Could your possible conflict of interest lead to private gain or loss at public expense?
- Can the decision be justified in terms of public interest?
- Would it withstand public scrutiny?

Conflict of Interest

A conflict of interest is a clash between private interest and public duty. There are two types of conflict:
 Pecuniary – regulated by the Local Government Act and Office of Local Government and, Non pecuniary – regulated by Codes of Conduct and policy. ICAC, Ombudsman, Office of Local Government
 (advice only).

The test for conflict of interest

- Is it likely I could be influenced by personal interest in carrying out my public duty?
- Would a fair and reasonable person believe I could be so influenced?
- Conflict of interest is closely tied to the layperson's definition of "corruption" using public office for private gain.
- Important to consider public perceptions of whether you have a conflict of interest

Identifying Problems

1st - Do I have private interest affected by a matter I am officially involved in?

2nd - Is my official role one of influence or perceived influence over the matter?

3rd - Do my private interests conflict with my official role?

Whilst seeking advice is generally useful, the ultimate decision rests with the person concerned.

MINUTES OF THE BLAND SHIRE COMMUNITY REFERENCE GROUP MEETING HELD IN THE BLAND SHIRE COUNCIL CHAMBERS ON TUESDAY 11 SEPTEMBER 2018 COMMENCING AT 6.30PM

WELCOME

Mayor Tony Lord welcomed everyone and opened the meeting at 6.34pm.

APOLOGIES

Cr Jan Wyse (Deputy Mayor), Ray Smith (General Manager), Sarah Gillett.

BUSINESS ARISING

1. West Wyalong Movies

Mayor Tony Lord told the meeting that following Ross Harmer's presentation at the previous Community Reference Group meeting, a Strengthening Communities grant application was submitted and approved by Council for \$4000 to assist West Wyalong Movies with the cost of producing a documentary centred on the history of West Wyalong's Main Street for release in 2019 as part of the 125th anniversary celebrations.

2. Tip fees and charges

Will Marsh advised that new tip fees and charges were implemented on 1 July as part of Council's 2018-2019 Revenue Policy, including some increased charges at the West Wyalong tip.

He advised that the increased charges that apply to car and trailer loads are a one off rise to counter the increased cost of operating the new street sweeper. Mayor Lord explained that Council is required to operate its waste management services at cost neutral and is not permitted to cross subsidise with rates or other income.

3. Green Waste Collection

Barry Cooper asked Council to consider a once a year green waste collection, possibly during spring, to assist residents to dispose of various large and small items of green waste.

Mayor Lord told the meeting that if there is sufficient support for the proposal, Council will need to obtain detailed costs to provide such a service as well as establish if and how the community is willing to pay for it.

Acting General Manager Will Marsh will investigate the matter further.

4. Microphones in Council Chambers

Barry Cooper suggested Council consider purchasing microphones/headsets for Councillors and guest speakers/presenters at Council meetings.

Mr Cooper said he sometimes finds it hard to hear Councillors and presenters during monthly meetings.

Jill Funnell said she also finds it hard to understand some Councillors and presenters on occasions when attending monthly meetings.

If there is sufficient support, Mayor Lord said Council would need to obtain costs for the provision of a suitable microphone system. While there are no funds allocated in the current budget, Mayor Lord said Councillors could consider the purchase and installation of microphones as part of its 2019-2020 budget deliberations.

5. Music Festival

A local resident put forward a suggestion for a music festival/event in West Wyalong.

It was agreed that Council further consider ideas for future events and/or festivals after the 125th anniversary celebrations of Wyalong and West Wyalong in March 2019.

In the meantime, the Mayor advised that Council has lodged a commitment free expression of interest with Co-Opera in hosting Opera in the Park in 2019 and Council is also pleased to have secured the Interactive Theatre Company's production of Fawlty Towers for September 2019.

6. Change and Feeding Room

A written suggestion was put forward by a local resident for discussion regarding a proposal for a change and feeding room separate from public toilets.

Mayor Lord said that change table facilities are currently available at Barnado Park, the Main Street toilets and VIC/library toilets in Shire Street. Will Marsh added that a second change table was being installed in the unisex toilet in Main Street.

Mayor Lord invited community feedback about a suggested location for a feeding/change table room, preferably without removing any of the existing public toilets in and around the CBD, and told the meeting that if an appropriate and viable location is identified, Council can then investigate further and obtain costings for consideration in its 2019-2020 budget.

7. 125th Anniversary of Wyalong and West Wyalong

Community Development Officer, Rebecca McDonell, and Community Relations Officer, Craig Sutton delivered a PowerPoint presentation highlighting the activities planned for the 125th anniversary celebrations of Wyalong and West Wyalong.

The presentation was positively received.

Mayor Tony Lord advised that Council has been shortlisted for an \$18,000 Federal Government grant for a walkway project to commemorate pioneering families and local historical figures as part of the 125th anniversary celebrations of Wyalong and West Wyalong in 2019. The gallery and wider community was invited to provide suggestions.

Councillor Liz McGlynn suggested Council consider a Wall to Wall art festival. It was agreed to further consider ideas for major festivals and events after the 125th anniversary celebrations of Wyalong and West Wyalong in 2019.

Jill Funnell enquired about the progress of a Council resolution to install hand rails and steps at the spectator seating areas at West Wyalong Stadium.

Councillor Murray Thomas queried the status of garzinnias as either a weed or a plant. If suitable, Councillor Thomas said garzinnias are drought resistant and










Blasting



- Once blast related event exceeded the maximum compliance level of 95 dB(L) at BM01 on Sunday 15 July 2018. Level recorded at 95.9 dB(L)





Reportable Incidents – NTSF Update



- On 21 April 2018, a minor seepage incident was observed on the eastern wall of the NTSF during route monitoring
- The seepage was predominately comprised of water with some tailings slurry material and clay also deposited
- The seepage was contained within the bund at the bottom of the current lift
- The processing plant was immediately shut down and pumping into the NTSF ceased
- Evolution notified EPA within 24 hours, and made notifications to DPE, DRG, DSC, DI-Water and other groups as required by the Development Consent (DA 14/98)
- Regulator inspections undertaken, and reporting provided
- No material harm to people or the environment
- Pumping into STSF was commenced following approval from the Engineer of Record

- On 14 May 2018, Evolution received a Section 240(1)(c) Notice under the NSW Mining Act, 1992 from the NSW Resources Regulator (within DPE)
- The notice(s) required Evolution to prepare a response and investigation report by 31 July 2018
- On 26 July 2018, Evolution provided a response to the Resources Regulator, including an investigation report prepared by AECOM (Engineers of Record)
- The investigation concluded that the seepage was the result of erosion of the clay liner as a direct result of cutting the droppers around the stage 5 lift of the NTSF
- The spigots were cut back to maintain subaerial deposition (instead of below the surface) and allow the layers of tailings to dry in an effort to enhance stability
- On 14 August 2018 the Resources Regulator finalised their investigation and confirmed that there had been no breach of the NSW Mining Act, 1992
- Notwithstanding, the remediation works on the NTSF are continuing

- THMS Transport of Hazardous Materials Study:
 - Approved in January 2006, under Condition 5.4(b)(i) of the Development Consent (DA 14/98)
 - Prepared as a pre-commissioning study that analysed routes, volumes, delivery frequencies, truck configurations etc for hazardous materials
 - Prepared in consultation with the EPS, RMS and various local councils
- Following initial approval of the THMS, five subsequent addenda were prepared and approved for further changes to the transport routes (2007 to 2017)
- In March and April 2018 Evolution undertook an internal audit against the requirements of the THMS and some inconsistencies were identified
 - Variations to the prescribed transport routes, supplier storage locations and volumes/number of deliveries
 - In many cases, the changes were the result of a change in supplier, or the closure of an existing route or facility
- These inconsistencies were notified to DPE on several occasions in May and June 2018
- On 8 June 2018, DPE-Compliance requested further information in relation to the possible non-compliances
- Evolution provided formal response on 2 July 2018

- Evolution has requested GPS tracking of recent deliveries of the relevant hazardous materials to confirm that the prescribed routes are being followed. This will occur on a regular basis


MOD14 – Summary



- Evolution has recently prepared the <u>Processing Rate Increase Modification</u> to support an increase to the throughput rate of the processing plant from 7.5 Mtpa to 9.8 Mtpa
- The key aspects of the Modification are:
 - Increasing the processing rate from 7.5 Mtpa to 9.8 Mtpa;
 - Development of an Integrated Waste Landform (IWL) surrounding the existing Tailings Storage Facilities for tailings and waste rock placement;
 - Duplicating the existing water supply pipeline across Lake Cowal;
 - Relocation of water management, soil stockpiles and other ancillary infrastructure (displaced by the larger IWL footprint) in a new Mining Lease Application (MLA) area;
 - Realignment of Lake Cowal Road around the new MLA;
 - Increased annual extraction of water from external water sources (e.g. surface water from Lachlan River);
 - Increase in the average and peak workforce employed at the CGO; and
 - Provision of crushed gravel to local Shire Councils and RMS
- This Modification was referred to the DoEE, and was subsequently determined to be a "Controlled Action"






MOD14 - Update



- The assessment process included a public exhibition phase to allow interested parties the opportunity to make comment on the Modification
- Public exhibition closed 15 May 2018
- Total of 29 submissions received
- Response to submission was submitted to the DPE on 7 June 2018
- Draft consent conditions have been received from the DPE and comments were provided by Evolution on 23 August 2018




Review of Environmental Factors (REF) Exploration Decline



- Evolution is seeking approval to construct an exploration decline within ML 1535 from the existing CGO open pit to allow underground exploration drilling and bulk sampling of the Galway, Regal and E46 resources
- The Activity would be located entirely within ML 1535
- The Activity would involve construction of a portal on an existing bench located off the main ramp of the open pit
- The exploration decline would extend from the portal to the north for approximately 1.4 km and would remain within the ML 1535 boundary
- The portal would be located so that no mining haul road realignment would be required in front of the portal
- Existing surface laydown areas at the CGO would be used, therefore, no additional surface disturbance areas would be required
- The information obtained from the Activity is essential to determine the technical, environmental and financial viability of any future open pit or underground mining associated with development of the CGO




CGO EXPLORATION DECLINE REF

- No additional surface disturbance associated with the Activity
- As Lake Cowal is hydraulically separated from the underlying groundwater systems (due to the very low permeability of the clay pan deposits that form the lake bed) no impacts on Lake Cowal or other surface water resources would result from the Activity
- Limited to minor incursion of highly saline groundwater from the fractured rock groundwater system is expected due to the geology of the host rocks. As there are no users of this groundwater system nearby, no impact on other groundwater users would occur
- Potential noise and blasting impacts associated with construction of the portal would be temporary in nature and are expected to be consistent with impacts associated with the approved operations at the CGO
- Ongoing noise impacts associated with truck haulage of waste rock is likely to be negligible compared with existing approved CGO noise impacts
- Potential impacts from underground blasting are expected to be imperceptible at privately-owned receivers
- Land subsidence is not expected due to the geology of the host rocks and the small size/dimensions of the proposed exploration decline



What are the next steps?

- Evolution has undertaken consultation with the DRG regarding the exploration decline
- A REF has been prepared in accordance with the ESG2: Guideline for Preparing a Review of Environmental Factors (DRG, 2015) and was lodged on 6 June 2018
- An associated MOP Amendment was prepared and lodged with DRG in August 2018
- Evolution is currently awaiting formal approval from DRG

9.2 Part Day Public Holiday Application – West Wyalong Show 2019-2020

Introduction

The West Wyalong Show Society has asked Council to apply to the NSW Industrial Relations Office for a part day public holiday between the hours of 12 noon and 6pm on Wednesday 4 September 2019 and Wednesday 2 September 2020 for the purposes of the West Wyalong Show.

Any application from Council for a local public holiday requires a formal Council resolution and must include the history of the event, an outline and evidence of extensive community consultation including written correspondence to stakeholders such as banks, schools and chambers of commerce, details of alternatives considered and transport arrangements for school students.

For a biennial application, applicants must also include additional information focusing on the economic and social importance of the event for the designated holiday area.

Financial Implications

Summary

For the sixth time in seven years, Council was required to undertake a widespread community consultation process in order to support any application for a local public holiday or local event day in the West Wyalong/Wyalong and Tallimba Town Improvement Districts

An online survey was published on Council's website and promoted through social media and press advertisements in the West Wyalong Advocate.

A total of 38 responses were received of which 35 (92 per cent) believe a holiday is necessary for the survival of the Show while 68 per cent of respondents favoured a part day public holiday (noon to 6pm) as requested by the Show Society and 21 per cent favour a half day public holiday (noon-midnight).

After previously supporting a half day holiday (noon-midnight), Council has applied for a part day public holiday (noon-6pm) each year since 2014 after receiving correspondence from the Australian Hotels Association (AHA) on behalf of its local members. The AHA expressed concern at the impact of a local half day public holiday and the payment of penalty rates for employees after 6pm when the Show had concluded. The Show Society has supported this stance

Meanwhile, the majority of survey respondents also identified positive community, social, local economy, tourism, employment and business impacts associated with the Show.

Comments received from community as part of the survey process for the consideration of Councillors were –

"The West Wyalong Show is a such standing tradition of this great little community and should be supported by all residents, business and council. It would be detrimental, in my opinion for it to not go ahead. Love the show."

"Many local organisations raise valuable funds through show catering etc so it does have a positive economic impact in this way.. Can't see the show surviving if volunteers don't have the afternoon off work and the school children get there after 3:30pm."

"The West Wyalong show is an important event for West Wyalong . We need events like this to maintain society cohesion in the town."

"The show is a major event in every town. Without a holiday people would not be able to attend the show till after work, there is not enough lighting to be able to ensure the safety of the public. If the public stop going to the show the oldest event in West Wyalong's history would not be able to run. Once it stops it will never get started again to the detriment of the town and district."

"If the 2019 and 2020 Shows are not gazetted as public holidays no one will be able to attend the show as children would be at school and adults would be at work."

"Why not consider moving the show to a weekend to limit disruption to the community. Paying penalty rates to employees that are not interested in attending the show does not fit well with anyone I have had contact with. If the show can't survive without it being mid week with a half day holiday I think it is doomed to fail anyway."

"I believe the West Wyalong Show is an important event on the local calendar showcasing local talent (pavilion) and products (Industrial pavilion etc). It is an important social event bringing the agricultural and residential communities together. A half day holiday allows individuals and families to attend the Show and experience the opportunities a rural Show provides."

"I think to be fair for all business involved in west wyalong that a half day local event day be declared. This is because business like pubs, clubs and supermarkets still stay open for the day as a requirement for the town. It is unfair for these businesses to be slugged with public holiday rates for this period while they are still trying to provide valuable services for the town and by closing for the required time for the show disadvantages the town and its economy greatly."

"This is an important event in the West Wyalong Community. It encourages locals and the communities to come together for a fun and entertaining day. It is important for adults and children to have something to look forward to each year...if this is not made a half day public holiday the attendance will certainly decrease and so the fun and social bonding with it."

"Without a public holiday, show day cannot & will not continue."

"I think if we can't have a 1/2 day holiday, then a half day local event day would be sufficient."

In addition to the survey, individual letters outlining the application process and seeking feedback were also sent to local banks, schools and Business West Wyalong. No return correspondence had been received at the time of writing this report.

The local public holiday has traditionally been declared in the Wyalong/West Wyalong and Tallimba Town Improvement Districts.

Recommendation:

That the Council make application for a local part day public holiday between the hours of 12noon and 6.00pm for the purpose of the West Wyalong Show on Wednesday 4 September 2019 and Wednesday 2 September 2020 covering the West Wyalong/Wyalong and Tallimba Town Improvement Districts within the Bland Shire area.

Council is in receipt of an Agreement relating to the conditions surrounding access to rail corridors for road works. This will mainly affect council when it is required to undertake works either within an operational or non operational rail corridor, or in close proximity to railway crossings.

It is not expected that this will occur on many occasions however all councils in NSW that have a rail corridor running through their area are being requested to enter into the same agreement.

It simply means that council will notify John Holland Rail when works are planned within the rail corridor.

An application for Local Heritage Assistance Funding has been received from Caroline Shaw for the repair and replacement of a concrete verandah floor at the side of 146 Main Street, West Wyalong, along the Church Street frontage.

The works include: the removal of the existing concrete and the installation of a 125mm concrete slab coloured red or green. A quote for the works has been provided to the value of \$15,630.00.

In accordance with the Heritage Funding Guidelines, the project is eligible for funding of up to \$5000.00

The premises are listed as a heritage item under the Bland Local Environmental Plan 2011.

The following is an extract from the NSW State Heritage Inventory:

Statement of Significance:

A landmark building of architectural merit on a prominent intersection, the building has retained its original character and significance and has a relationship with the three older buildings on the opposing corners. The building has historic and aesthetic significance. It forms a focal point at the main intersection in the town centre and the building contributes to the Conservation Area.

Financial Implications

There is currently \$23,000 of unallocated funds in the Local Heritage Grants budget.

Summary

The project is consistent with the Local Heritage Fund Guidelines as the proposed works do contribute to the external heritage fabric of the building.

Recommendation:

That Council approve funding of \$5000.00 for the repair and replacement of the verandah flooring at 146 Main Street, West Wyalong.

Grant applications

Council has assisted a number of local sporting organisations with grant applications under the Federal Government's new sports infrastructure program.

Council worked directly with representatives from Ungarie Netball and Basketball, the Weethalle Recreation Ground Committee, West Wyalong Horse Sports and Rodeo Club, West Wyalong Swimming Club and West Wyalong Tennis Club to assist in the preparation and submission of significant grant funding.

Council has also submitted an application under the Safer Communities Fund to fully fund the installation of CCTV cameras at the West Wyalong Skate Park, Barnado Park and McCann Park.

Federal Member for Riverina, Michael McCormack, has also advised that Council has been shortlisted for funding under the Stronger Communities Fund for an historical walkway as part of the 125th anniversary celebrations.

Meanwhile, State member for Cootamundra, Steph Cooke, was due to announce the successful recipients under the Stronger Country Communities Fund in West Wyalong on Wednesday 12 October.

Artstate NSW

The Chief Executive Officer of Arts NSW, Elizabeth Rogers, has invited the Community Development Officer and Community Relations Officer to make a presentation at the statewide arts conference, ArtState, in Bathurst on 1-4 November. The presentation will highlight Council's initiative in delivering the Weethalle Silo Art Project and the Big Football in Ungarie.

West Wyalong High School partnership agreement

Bland Shire Council has entered into an historic agreement with West Wyalong High School providing students with the opportunity to commence school based apprenticeships or traineeships. This will enable students to attain a nationally recognised Vocational Education and Training (VET) gualification as well as their Higher School Certificate.

The Partnership Agreement for Career Transition (PACT) is a joint agreement to enhance the career opportunities available at Bland Shire Council to students at West Wyalong High School through three key partnerships - Work Experience, School Based Traineeships and Apprenticeships (SBATs) and the provision of Industry Access such as school visits, presentations and mentoring.

Under the agreement, Council will -

- Support a minimum of two new School Based Traineeships and Apprenticeships annually until at least 2021
- Provide up to 10 work experience placements each year
- Support the West Wyalong High School Career program by providing staff and resources for career information activities, access to Council sites for student visits and provide mentoring opportunities to High School students.



Youth engagement

As part of the new partnership agreement, the Community Relations Officer and Community Development Officer are working with students on planning a Community Expo in December and updating and modernising Council's Community and Business Guide.

Students have also met with a number of community groups to offer assistance to create promotional material highlighting the work of each group.

The CDO and CRO were also invited to address and work with year eight geography students on a unit of study where they are required to plan their own town.

This follows a successful Mayoral forum held at Ungarie Central School in August.

Furthermore, community services have recently facilitated two work placement students from West Wyalong High School and will host a student from Ungarie Centre School for a week in November.

School holidays

As part of its school holiday program, Council once again hosted the NRMA Driving School on 3-4 October. For the first time some lessons were made available in the evening to assist learner drivers to gain expert tuition and experience driving at night.

Bland Shire Library recently engaged Bernard Caleo – author, illustrator, storyteller and performer – as a guest speaker. Mr Caleo visited schools throughout the Bland Shire sharing with students and staff his skills and extensive knowledge of comic art and graphic storytelling.

Mr Caleo, who is from Melbourne and has his own publishing company Cardigan Comics, presented 18 sessions over five days to some 700 students, Kinder to Year 9. He was totally engaging – impressing everyone with his passion and excitement about comics. His style was both energetic and humorous with the students absolutely enthralled with his animated and fast paced approach. While Mr Caleo incorporated a graphic art/comic workshop into some of his sessions for older students, the main focus of his presentation was 'kamishiba', a form of Japanese street theatre and storytelling which the children found fascinating. From all accounts, another very successful author visit and judged by many as one of the best.

It should be noted that with the cost of hosting an annual author visit – something the library has been doing for the past twenty years – on the rise, the library was grateful to receive a Cowal Partnering Grant to assist with funding this year's visit.

Bland Home and Community Care Service continues to receive a large number of enquiries regarding available services within the area. As Council provides such a variety of services to both Aged and those with a disability, many enquiries are received regarding available services with staff providing as much information as possible.

The CHSP services provided by Bland Shire Council are funded under the same agreements as Meal on Wheels and Community Transport, however many people within the community believe they are Council funded, which is not the case.

Due to the recent funding changes, there is no allowance for the provision of information – all funding is output relate. However; this poses an issue for staff and there is increased demand in this area with no funding to support the time the staff require to provide the service.

NDIS services are still rolling out in our area with some people just putting their plans into action. With the number of enquiries and services requested, staff need to be flexible in their approach and often think outside the box to meet the needs of some participants. Council, as providers of NDIS services, are providing services and information that we may not have thought of previously but our approach is working with positive feedback being received. We will continue to offer services when we can and feel the NDIS area will grow more and more in the coming months and years.

Our social groups had a busy month in September with a trip to Temora and to WWHS MPU for the Feel the Beat show put on by West Wyalong Public School. It is great that the Social services we offer give clients the opportunity to visit areas and see things they would not otherwise be able to. It is also nice to see the friendships made and how the groups interact, for many of the clients it is the only outings they have from week to week.



Our Tech Talk group is going well with the clients amazed at what theya re learning. Part of this program is to empower the group, increase their knowledge and it is also nice to see the members of the group helping each other. Mobile phones have been the main thing people want to learn about with some learning about tablets and laptops. This group will continue to run while needed and we welcome new members, it is not something that you need to attend every week or have been attending since the start.
