#### 6.0 PUBLIC FORUM

#### 6.1 Mrs Wendy Seaman – Author Dymphna Cusack

Mrs Seaman addressed Council in relation to author Dymphna Cusack who was born in Wyalong on 21 September 1902. She believes that the recent increased arts profile within our community creates an opportunity to promote Dymphna Cusack and her birthplace. Mrs Seaman provided an overview of Ms Cusack and her works.

# 6.2 Mr Andrew Buttenshaw – Working together for the benefit of tourism and for the Bland Shire

Mr Buttenshaw addressed Council in relation to a range of suggested tourism initiatives and expressed his disappointment that the discussion paper and recommendations therein were not made available to the public. He stated that he was happy to see the tourism profile being raised within our community and expressed the need to work together. Mr Buttenshaw requested a public forum be held to enable everyone to have their say and develop appropriate solutions together that will be carried forward by the community and Council.

#### 7.0 MAYORAL MINUTE

In this month's LG Focus, the Local Government sector magazine covering Australia, there is an article relating to the new powers being given to Mayors in Victoria to help them contain unruly behaviour from Councillors. Far from making any inference that such an issue exists within our Council I would still like to refer to a number of paragraphs contained in the article because I believe they are relevant to us all.

The Minister said "Council meetings are for important discussion and decision making and cannot afford to be marred by inappropriate Councillor behaviour. In the past some Councillors have thought they can get away with unruly, disrespectful and inappropriate behaviour during Council meetings – this must stop."

"The Minister said Councillors must lead by example acting with respect and integrity, in a way that encourages public confidence in the office of Councillor.

I believe the article is a timely reminder to us all as Councillors, that what we do and the way we go about doing it, is always under scrutiny particularly in the context of our small community in Bland. This applies not only to our conduct during formal Council meetings but also to our involvement in activities and interactions with our community. What we do and what we say in the community is also very relevant to our Councillor role. What we do and say in the community can reflect not only on you as an individual Councillor but also on your fellow Councillors as a group.

We are facing a period of new challenges and opportunities for our Shire. A lot of work has already been done that places our Council in a position of strength to face the future. Past consultations, discussions and decisions have produced the Plans and Strategies we have available to use as valuable resources today. It has been stated and acknowledged that these documents are "living documents" They have the flexibility to change with the changing nature and expectations of our community. We will continue to work to achieve success.


## 10.18 Main Street Toilet- Upgrade
